The Meeting is invited to <u>elect</u> a Chair and vice-Chair for the HELCOM Group on sustainable fisheries (Fish) for the two year period 2016-2018.

### Agenda Item 3 Matters arising from other HELCOM work of relevance for the Group

The Meeting is invited to <u>take note</u> of the outcomes of recent HELCOM meetings of relevance for Fish, including the <u>HELCOM explorer</u> to be presented by the Secretariat.

The Meeting is invited to consider a draft of the HELCOM Maritime Assessment, especially the Fisheries and Aquaculture chapters (document to be submitted at a later stage).

## Agenda Item 4 Follow up of the draft HELCOM Recommendation on sustainable aquaculture

The Meeting is invited to <u>take note</u> of a list of nominated contacts of the HELCOM Fish Correspondence Group concerning a draft document on BAT/BEP descriptions for sustainable aquaculture in the Baltic Sea region (CG Aquaculture) (document to be submitted at a later stage) and <u>select</u> a lead country for the Correspondence Group. The Contracting Parties who have not yet nominated a contact for CG Aquaculture are invited to do so in advance of the Meeting.

The Meeting is invited to <u>take note</u> of the status of an application to the Nordic Council of Ministers on a project to support the task to provide a concise compilation of existing BAT and BEP techniques from CG ToR.

## Agenda Item 5 Interactions between fisheries and marine ecosystems

Adjustment or utilization of EU data collection framework

The Meeting is invited to take note that, based on consultations by HELCOM Fish and HOD, a letter with HELCOM recommendations for the EU Data Collection Framework (DCF) revision was sent to the EU Commission on 25 May 2016, opening a communication channel between HELCOM and the EU process.

The Meeting is invited to <u>consider</u> how to follow up the DCF revision letter including specifying further details based on HELCOM data needs, as well as identifying a best timing of and channels for such additional input.

Testing alternative fishing gears/fishing techniques

Poland is invited to present the questionnaire on alternative fishing gears or fishing techniques amended after FISH 4-2016 for the Meeting.

Denmark is invited to present information on an initiative to protect the harbour porpoise from fisheries in Danish waters.

Mitigating eutrophication effects by fish management

The Meeting is invited to <u>consider</u> further steps regarding the topic on mitigating eutrophication effects by fish management, as agreed by FISH 4-2016.

Seals-fisheries interactions

The incidental catch subgroup under the HELCOM Seal expert group is invited to present work undertaken on seals-fisheries interactions as invited by FISH 4-2016.

The Meeting is invited to <u>consider</u> the information and potential for any follow up activity including drafting of a HELCOM Recommendation on seals-fisheries interactions.

### Fisheries and MSP

The Meeting is invited to share any information on Fish and Fishing in Maritime Spatial Planning (MSP).

Cooperation between fisheries/aquaculture and environmental organizations

The Meeting will be invited to <u>take note</u> of the outcome of the event "Sustainable Ocean Initiative Global Dialogue with Regional Seas Organizations and Regional Fisheries Bodies on Accelerating Progress Towards the Aichi Biodiversity Targets", 26-29 September of 2016 in Seoul, South Korea.

The Secretariat will present the Meeting with a draft communication plan to facilitate information exchange between HELCOM, BALTFISH and aquaculture advisory council, including potential common topics and communication pathways (document to be submitted at a later stage).

The Meeting is invited to consider the plan and amend it as appropriate.

#### Ghost nets

Finland and Sweden are invited provide information on the ongoing work regarding ghost nets.

The Meeting is invited to <u>consider</u> the information and potential for drafting a HELCOM Recommendation on ghost nets.

# Agenda Item 6 Recreational fisheries

A representative from BALTFISH is invited to present information on recreational fisheries activities under BALTFISH to the Meeting.

A representative from ICES Working Group on Recreational Fisheries Surveys is invited to provide information on existing data collection requirements for recreational fisheries to the Meeting.

The Meeting is invited to <u>take note</u> of the ICES advice to EU on recreational cod data needs for monitoring the recreational fisheries (document 6-1).

ICES is invited to present recent advice on the data needs for monitoring recreational cod fisheries.

The EU is invited to report on recreational fisheries as part of the EU DCF revision.

The Meeting is invited to <u>consider</u> the "measures" section of the HELCOM assessment on coastal fish under preparation by HELCOM FISH-PRO II as a basis for HELCOM measures in the field of recreational fisheries (document to be submitted at a later stage).

### Agenda Item 7 Migratory fish species

The Meeting is invited to <u>adopt</u> the amended draft work plan of HELCOM task force on migratory fish species (Fish-M), as proposed by FISH-M 3-2016, and <u>nominate</u> intersessional leads for the focus topics.

The Meeting is invited to <u>consider</u> and <u>endorse</u> the amendments to the HELCOM Recommendation 32/33-1 'Conservation of Baltic salmon (Salmo salar) and sea trout (Salmo trutta) populations by the restoration of their river habitats and management of river fisheries' proposed by the FISH-M 3-2016 meeting as a basis for further work in implementing the Recommendation.

Poland is invited to <u>inform</u> on any progress on the sturgeon rehabilitation project.

The Meeting is invited to <u>take note</u> of the ICES advice to EU on potential management measures for salmon in the Gulf of Finland (ICES Subdivision 32) (document 7-1).

The Meeting is invited to **share** other information on migratory species.
